

- From SOLTRA we inform that we maintain an Environmental Management System, which affects your relationship as a SOLTRA supplier in the following matters:
- For the selection of our suppliers, we consider environmental criteria, so whenever possible we need you to offer us the product variety that is most environmentally friendly.
- The legal requirements of an environmental nature that apply to each product service / supply must be met, so in the event that some type of document, certificate, etc. is required. (to check compliance with said regulations), it will be provided prior to the start of its services. Failure to comply with it may be grounds for termination of the service / product you provide us. As a general rule, these documents will be those indicated in the following table:

SUPPLIER / SUBCONTRACTOR TYPE	SPECIFIC ENVIRONMENTAL REQUIREMENTS
All providers	Comply with general environmental requirements.
Non-Hazardous Waste Manager	Accreditation as an Authorized Manager. Delivery certificate of withdrawal / quantities.
Hazardous Waste Manager	Accreditation as an Authorized Manager. Accreditation amounts withdrawn. Delivery of the documentation of each withdrawal required by regulations: Acceptance document, notification of transfer, admission application, control and monitoring document.
Calibration Laboratories for Control Equipment and Instruments.	Accreditation of the capacity to carry out the calibrations issued by ENAC.
Installation and Equipment Maintenance Companies	Remove all kinds of waste generated in our facilities. Comply with the procedures of the SOLTRA Environmental Management System. Communicate the environmental effects that your activities generate in our facilities.

If you work or supply us within our facilities, you must remember to comply with these operational standards:

You must meet the criteria that have been included in the signed contract or, failing that, in the "environmental requirements" statement that has been provided to you.

You must consume resources respectfully while you are in our facilities (Electricity, water, paper, other consumables, etc.).

Do not dump pollutants in the company's facilities (either sewage or soil). In the event of an accidental spill (example during the unloading of the products), consult the staff on how to collect the spill and what to do with the waste generated.

Regarding waste, it will comply with the following standards:

It will carry out, as much as possible, the correct separation of the waste it generates due to its work. To do this, you must remember that the waste is separated into three containers: Containers (yellow), paper / cardboard (blue), organic matter and others (gray).

In the event of generating other types of waste that is not urban waste, the specific container or area that exists in the facilities must be used for this purpose (if there is not prior consultation).

In the event that some type of hazardous waste is generated due to your work, you must manage it correctly by delivering it to an authorized manager or at a clean point. Documentation may be required to prove such management.

In the event that your job involves driving vehicles, we remind you that the Vehicle Inspection Test must have passed the date, according to regulations. Likewise, we inform you that to prevent air pollution (noise and emissions) it is necessary to carry out responsible driving, which implies: Respect speed, do not unnecessarily turn off and start the vehicle, maintain a constant speed (do not drive randomly, accelerating and braking without need).
